AB Announces October 31, 2019 Assets Under Management

New York, NY, November 12, 2019 - AllianceBernstein L.P. ("AB") and AllianceBernstein Holding L.P. ("AB Holding") (NYSE: AB) today announced that preliminary assets under management increased to \$601 billion during October 2019 from \$592 billion at the end of September. The 1.5% increase was due to market appreciation, as well as total firmwide net inflows. By channel, net inflows to Retail exceeded net outflows from Institutions and Private Wealth.
