# ***AB Managed Volatility Equities Fund (Managed Fund) – MVE Class***

### **1. Target Market Summary**

This product has been designed for consumers who have a high risk and return profile and are seeking an investment in a portfolio of Australian and some international equities which offer the potential for capital growth with lower volatility than is typical for equity investments. The consumer would typically have at least a five-year investment timeframe and be unlikely to need to withdraw money on less than one week's notice. The consumer would only seek to use the product for 25% or less of the total investable assets held by that consumer as part of a more broadly diversified portfolio of assets. The consumer would also typically have first obtained personal advice before making an initial investment in the product.

This Target Market Determination (**TMD**) is required under section 994B of the *Corporations Act 2001* (Cth) (**the Act**). This TMD describes the class of consumers that comprises the target market for the financial product and matters relevant to the product's distribution and review (specifically, distribution conditions, review triggers and periods, and reporting requirements). Distributors must take reasonable steps that will, or are reasonably likely to, result in distribution of the product being consistent with the most recent TMD (unless the distribution is excluded conduct).

This document is **not** a product disclosure statement (**PDS**) and is **not** a complete summary of the product features or terms of the product. This document does not take into account any person's individual objectives, financial situation or needs. Persons interested in acquiring this product should carefully read the PDS for the product before making a decision whether to buy this product.

### 3. Description of Target Market

#### Appropriateness

The Issuer has assessed the product and formed the view that the product, including its key attributes, is likely to be consistent with the likely objectives, financial situation and needs of consumers in the target market, as the features of this product in Column 3 of the table below are likely to be suitable for consumers with the attributes identified with a green TMD Indicator in Column 2.

#### Investment products and diversification

A consumer (or class of consumer) may intend to hold a product as part of a diversified portfolio (for example, with an intended product use of *minor allocation*). - Any significant dealing outside of target market, under s994F(6) of the Act. This information will be collected as soon as practicable but no later than 10 business days after distributor becomes aware of the significant dealing.

<b>Review triggers</b>	<p>The following events that could potentially give rise to the view that this TMD is no longer appropriate include:</p> <ul style="list-style-type: none"><li>• Material changes to key attributes of the fund including investment objective or product design.</li><li>• Significant deviation from benchmark/ objective over sustained period.</li><li>• Failure of key attributes to perform as disclosed by a material degree and for a material period.</li><li>• Materially high number of complaints (as defined in section 994A(1) of the Act) about the product or distribution of the product.</li><li>• Determination by the issuer of an ASIC reportable Significant Dealing.</li><li>• The use of Product Intervention Powers, regulator orders or directions that affects the product</li></ul>

Following the issuer receiving notification of an occurrence of one of these review triggers, this TMD will be reviewed within 10 business days.

## Definitions

<p>This TMD uses the Standard Risk Measure (<b>SRM</b>) to estimate the likely number of negative annual returns for this product over a 20 year period, using the guidance and methodology outlined in the <b><u>Standard Risk Measure Guidance Paper For Trustees</u></b> (note the bands in the SRM guidance differ from the bands used in this TMD). However, SRM is not a complete assessment of risk and potential loss. For example, it does not detail important issues such as the potential size of a negative return (including under conditions of market stress) or that a positive return could still be less than a consumer requires to meet their investment objectives/needs. The SRM methodology may be supplemented by other risk factors. For example, some products may use leverage, derivatives or short selling; may have liquidity or withdrawal limitations; may have underlying investments with valuation risks or risks of capital loss; or otherwise may have a complex structure or increased investment risks, which should be documented together with the SRM to substantiate the product risk rating.</p> <p>A consumer's desired product return profile would generally take into account the impact of fees, costs and taxes.</p>

Where a product is held on investment platforms, distributors also need to factor in the length of time platforms take to process requests for redemption for underlying investments. Where access to investment proceeds from the product is likely to occur through a secondary market, the liquidity of the market for the product and likely realisable value on market should be considered, including in times of market stress.</p>

<b>Distributor Reporting</b>	
Significant dealings	<p>Section 994F(6) of the Act requires distributors to notify the issuer if they become aware of a significant dealing in the product that is not consistent with the TMD.
