By providing the Trusted Contact Person information below and signing this form, I authorize AllianceBernstein Investor Services, Inc (ABIS), as agent for the AB Funds, in its sole discretion, to communicate with the Trusted Contact Person, verbally and/or in writing, and to disclose to the Trusted Contact Person non-public personal information* about my fund accounts to:

- Confirm the identity of any legal guardian, executor, trustee or holder of a power of attorney; or as otherwise permitted under FINRA Rule 2165 (Financial Exploitation of Specified Adults) or federal or state law

Important Information Regarding the Trusted Contact Person: Designating a Trusted Contact Person is not required and does not authorize the Trusted Contact Person to transact on or make changes to the account owner's Fund accounts. Only one person may be appointed to serve as a Trusted Contact Person at any time on any Fund account.

A Trusted Contact Person must be at least 18 years of age. A Trusted Contact Person should not be someone already authorized to transact business on the account(s), or who is already otherwise able to receive the information described below, such as a joint account holder or a power of attorney agent.

I may revoke this Trusted Contact Person information at any time by delivering to ABIS a signed written revocation instrument or by completing a new Trusted Contact Person Form. A revocation by signed written instrument or by the provision of a new Trusted Contact Person Form will be effective on receipt by ABIS.

The designated Trusted Contact Person will be appointed to the fund and account specified below and any other AB Fund (the Fund) account(s) that I currently hold and/or will open in the future. I understand that there is no requirement for ABIS to contact my Trusted Contact Person. By signing the Trusted Contact Person Form, I and my heirs hold ABIS harmless if it either acts, or does not act, on my stated preferences based upon ABIS' sole discretion.
