1. Cookie and Tracking Statement Summary

1.1. Summary

AB uses cookies and tracking software to monitor visitor traffic patterns and site usage in order to develop the design and layout of the Website to better meet the needs of visitors to the Website. We ask for your consent to use cookies that collect your personal information, although we also use other types of cookies that do not collect your personal information and/or are necessary for the website to function.

The aim of this document is to provide you with a summary of the cookies and tracking technologies we use and how you can control use of these technologies.

1.3. Overview

This Cookie Policy should be read in conjunction with our [Terms and Conditions](#) and our [Privacy Policy](#). This Cookie Policy covers AllianceBernstein and its affiliates (for the purposes of this document, "AB").

2. What Are Cookies?

2.1 Cookies and Tracking Technology Overview

When AB refers to "cookies" we are generically referring to the tracking technologies on our websites and marketing communications including:

- Cookies
- Web Beacons
- Pixels
- Log files
- Other similar technologies

2.1.1. Cookies

A computer cookie is a small file that is issued to, and stored on, your computer when you visit a website. The information stored relates specifically to the computer accessing the website and the cookie can be accessed by both the web server and your computer.

Cookies are used for a wide range of purposes, such as identifying a computer's previous visits to a website, ascertaining the most popular features of a website or enable a company to present specific information to users.

2.1.2 Web Beacons

To help us better manage content we employ web beacons in marketing emails we send.



Web beacons are small graphics placed on websites or in emails with a unique identifier. Unlike cookies, which are stored on your computer hard drive, web beacons are embedded invisibly on websites or in emails.

We use web beacons in our HTML-based emails to learn which emails have been opened by recipients enabling us to gauge the effectiveness of our marketing campaigns.

You can opt-out of these emails by following the unsubscribe instructions within marketing emails.

2.1.3. Pixels

A pixel refers to the code that is placed on your computer to trigger a cookie. We sometimes use this methodology to allow us to deliver more relevant messages to you.

2.1.4. Log Files

Log files are records of events that occur on our websites. These audit trails allow us to analyze activities on our websites and are important for ensuring website performance and security.

2.1.5. Other Technology

This policy may be updated periodically to reflect any material changes or updates in technology we employ.

2.2. Cookies and Tracking Technologies Used on This Site—How We Use Them and Why

2.2.1. Cookies: Type and Duration

There are two types of cookies:

- “Session Cookies”—Stored temporarily in your computer's memory while you are visiting the site and deleted when you close your browser
- “Persistent Cookies”—Stored for a set period on your computer and used to determine whether there has been any contact between us and your computer in the past

2.2.2. Companies Setting Cookies on Our Website

When you visit our web-site cookies set can be:

1. “1st Party Cookies”—cookies that are set by the website, for example alliancebernstein.com
2. “3rd Party Cookies”—cookies that are set by another website domain e.g.
 - One of our technology partners
 - External web services
 - Marketing agencies and other affiliates

2.2.3. Cookies: Classification

We categorize cookies set on our sites by ourselves and our main technology partners into the following categories

- Strictly necessary cookies. These cookies are essential, as they enable you to move around a website and use its features, such as accessing secure areas. Without these cookies, services you've asked for (such as access to secure areas) can't be provided. These cookies don't gather information about you that can be used for marketing or remembering where you've been on the internet
- Performance cookies. These cookies collect information about how you use a website, for example which pages you go to most often and if you get any error messages from certain pages. These cookies don't gather information that identifies you. All information these cookies collect is anonymous and is only used to improve how our website works. These cookies are not used to target you with online advertising. Without these cookies we can't learn how our website is performing and make relevant improvements that could better your browsing experience
- Targeting/Functionality cookies. These cookies allow a website to remember choices you make (such as your username, language or the region you're in) and tailor the website to provide enhanced features and content for you. For instance, they can be used to remember log-in details, changes you've made to text size, font and other parts of pages that you can customize. They may also be used to provide services you've asked for such as watching a video or commenting on a blog. These cookies may be used to ensure that all our services and communications are relevant to you. The information these cookies collect cannot track your browsing activity on other websites. Without these cookies, a website cannot remember choices you've previously made or personalize your browsing experience



- Analytics cookies: These cookies allow AB to measure traffic and interactions on our website, enabling AB to both measure the effectiveness of our website content and to make improvements to the site's user experience based on this data.
- Advertising cookies: AB partners with various marketing agencies who place ads on our behalf on third-party websites, including search engines like Google and Bing. These cookies are used to measure the success of these advertisements while also ensuring that relevant content is presented on AB's sent when visited via one of the ads. No personal information is sent to these third-party sites or marketing agencies and no personal information is transmitted from these third-party sites to AB.

2.2.4 AB Use of Cookies

Our various websites use cookies from each category above to establish sessions with our servers, record acceptance of terms and conditions, Authentication (for access to secured sections of our website), personalization of your browsing experience and for monitoring the security and performance of our technology platform. AB does not share information with third parties for other marketing purposes.

We work directly with technology partners to maintain and support our website including, but not limited to:

Provider	Summary of Purpose and Data Collected
AB	Acceptance of terms and conditions and device and preference information to improve the user experience including default pages and optimizing the desktop and mobile device user experience. Session cookies are used to temporarily save user data.
Pardot (Salesforce); Marketo (Adobe)	Visit information (pages viewed), anonymous visitor information (host name). If the user is signed into our site, or the user is in Pardot/Marketo, their activity on the web site is linked back to their contact record.
Adobe Analytics	Visit information (pages viewed, time spent, page depth, etc.), anonymous visitor information (location, device, operation system, domain, screen resolution, referring domain, etc.), individual visitor information if logged in (US retail only—name, dealer, sales with AB, etc.)
OneTrust	Tracking of user agreement to the use of cookies.
Meta	Meta ad-driven website visitor activity after visitor has clicked on an Instagram or Facebook ad.
LinkedIn	LinkedIn ad-driven visitor activity on website. Provides data on campaign reporting, conversion tracking, retargeting and audience insights.
Google	Google Floodlight cookies, or more accurately, Floodlight tags and activities, are used to track user actions across a website to measure advertising campaign performance and conversions, as well as for re-targeting during return visits to our site.



Demandbase	Demandbase is an account-based marketing technology platform that AB partners with both for capturing company/account level information (using anonymous visitor information such as host name or I.P. address) and advertising on third-party sites, including search engines like Google and Bing.
