AB Announces July 31, 2019 Assets Under Management

New York, NY, August 12, 2019 - AllianceBernstein L.P. (“AB”) and AllianceBernstein Holding L.P. (“AB Holding”) (NYSE: AB) today announced that preliminary assets under management increased to \$585 billion during July 2019 from \$581 billion at the end of June. The 0.7% increase was due to market appreciation, as well as total firmwide net inflows. By channel, Retail net inflows were partially offset by outflows from Institutions and Private Wealth.
